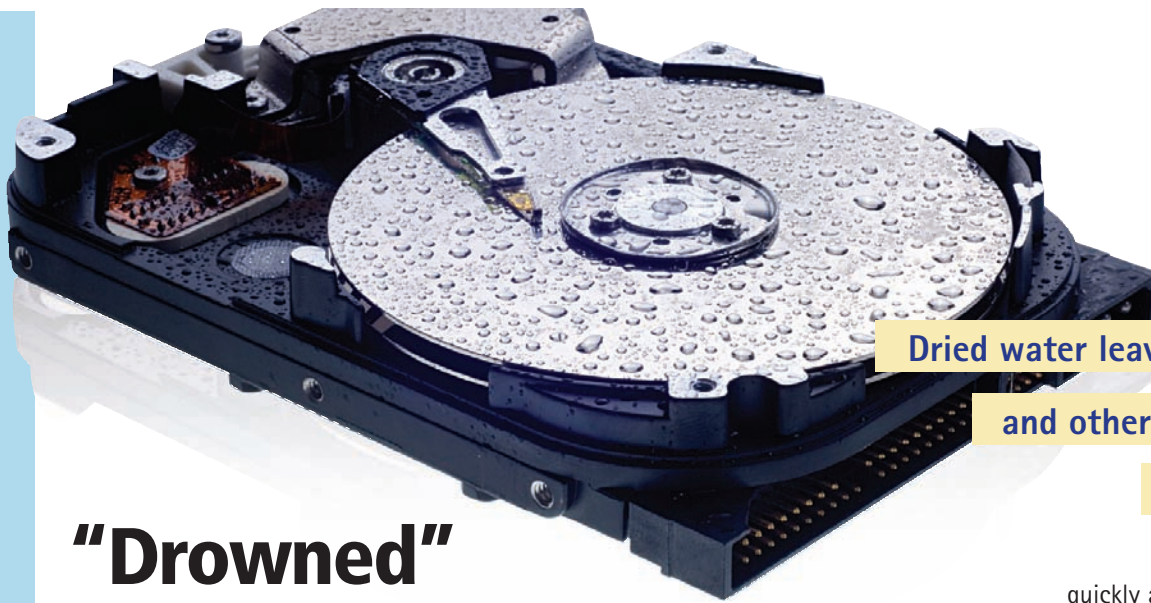

“Drowned” Computers; Can The Data Be Saved? The Pros Say Yes!

The computer itself cannot always be saved, but the data from it often can. And you can help.

The Louisiana State Government Offices recommends that once you discover that your electronic media storage sources are wet, “Write down passwords and filenames as soon as possible so you do not forget them later. Rinse media that has been exposed to mud, sewage or sea water with tap water as soon as possible. Magnetic media that is wet should be kept wet so contaminants don’t dry on tapes and diskettes, place them in water filled plastic bags to preserve.” FEMA adds, “If a computer disk or tape has valuable information, rinse it in clear water and put it in a plastic bag in the refrigerator. Later, you can take it to a professional drying center and have the data transferred to a good disk or tape.” And the APApractice.org says, “In the case of water damage do not attempt to restart or reboot your computer. While the computer drive may seem dry, small amounts of water may linger on internal or external components, causing a short when power is restored. “Do not dry a wet drive or media. Place them in a plastic bag with an airtight zip closure as

quickly as possible. Dried water leaves mineral deposits and other contaminants on the media surface that can lead to a crash when power is restored.” There are data recovery experts who work with the Contents Restoration Specialists to recover information from damaged data systems. Many of them are using an immersion process, along with new, low water, technologies that rely on controlled sprays, air guns to remove surface contaminants and air movers to ventilate harmful vapors. Most of these companies offer a free evaluation of your data recovery project so there is no charge for examining whatever hardware you provide. If they are unable to retrieve the information from your hard drive, discs etc., there is no charge for their initial examination. Not All Restoration Professionals are Created Equal

Recently there was a story in print in which two restoration professionals (not contents management specialists) were seen tossing a collection of porcelain dolls, one to the other, then carelessly putting them in a box. Two of the dolls were broken (one had been appraised at \$11,500, the other for \$9,500).

A *Contents Restoration Specialist* has been trained and certified in precise “pack out” procedures designed to protect, transport and restore valuable items, including everything from fine art to computer hardware, to rare books, leather, furs, photographs and more.

Make sure you are dealing with a contents restoration specialist when you have items of value to be removed or restored. They cost the same as an average restoration company and they are worth a great deal more when fragile, rare or irreplaceable items are being saved.

When hiring a restoration company, make sure they have personnel who are trained in the specialty of contents restoration, to the standards recommended by organizations such as the Restoration Industry Association (RIA), or the Institute of Inspection, Cleaning, and Restoration Certification (IICRC).

What can you do with equipment and furniture to protect them against further damage by rain, humidity, mold growth, and looting? The Ultrasonic Difference

Frank Pedeflous of Omegasonics says that Ultrasonic processing revolves around the science of cavitation, which creates millions of tiny bubbles that implode upon surface contact. These implosions create a vacuum vortex that pulls soot, corrosion and other contaminants from the surface of damaged contents.

Because the items are submerged in water, the high frequency sound bubbles travel everywhere water permeates. The benefit is a thorough cleaning of internal areas of fine collectibles like high-detail collectibles like Hummels, small appliances and electronics. Additionally, unpleasant odors are also virtually eliminated. Items cleaned by hand look clean on the outside but may remain contaminated and retain a smoky or musty smell.

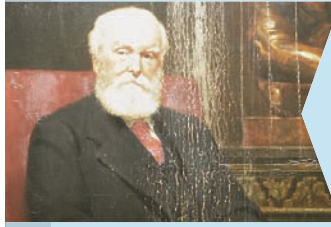

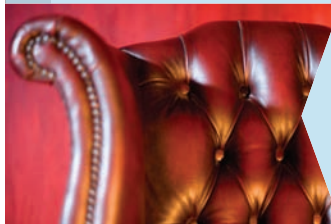
